2. This Court has jurisdiction over the subject matter of this litigation and
personal jurisdiction over the named-Plaintiff, all settlement class members, and
Defendant.

3. The Court confirms as final the following settlement class pursuant to Nev. R. Civ. P. 23: "all hourly paid non-exempt persons employed by Defendant in the state of Nevada who earned less than 1 ½ times the applicable minimum wage and who worked over eight (8) hours in a workday at any time from August 26, 2016 until June 22, 2022."<sup>1</sup>

 The Court confirms the appointment of Monique Kennedy as the Class Representative and the enhancement payment of \$15,000.00 to Monique Kennedy, as set forth in the Settlement.

5. The Court confirms the appointment of Mark Thierman, Esq., Joshua Buck, Esq., and Leah Jones, Esq., of Thierman Buck LLP and Christian Gabroy, Esq., and Kaine Messer, Esq., of Gabroy | Messer as class counsel for the settlement class and approves their requests for attorneys' fees of \$282,833.33 and actual litigation costs under NRS 18.005 of \$5,726.64, respectively.

The class notice was distributed to class members, pursuant to this
 Court's orders, and fully satisfied the requirements of Nev. R. Civ. P. 23 and any other
 applicable law.

Pursuant to Nev. R. Civ. P. 23, the Court grants final approval to this
Settlement and finds that the settlement is fair, reasonable, and adequate in all
respects, including the attorneys' fees, costs, and incentive award provisions. The
Court specifically finds that the settlement confers a substantial benefit to settlement
class members, considering the relative strength of plaintiff's claims and defendant's

defenses and the risk, expense, complexity, and duration of further litigation. The response of the class supports settlement approval. No class members objected to the settlement and none requested exclusion from the settlement. The Court further finds that the settlement is the result of arms'-length negotiations between experienced counsel representing the interests of both sides, which supports approval of the settlement in accordance with the standards set forth in the joint motion for final approval of settlement.

8 8. The Court finds that as of the date of this Order each and every class
9 member has waived and released claims as set forth in the Settlement and Notice of
10 Class Action Settlement (the "Notice").

9. The Court finds that the Claims Administrator ILYM Group, Inc. is entitled
 to \$15,000.00 for administrative fees.

13 10. The Court directs the parties to effectuate the settlement terms as set 14 forth in the Agreement and the Order Granting Preliminary Approval of Class Action 15 Settlement entered herein on June 22, 2022 ("Preliminary Approval Order"). 16 Consistent with the Agreement and Preliminary Approval Order, the Defendant shall 17 fund the settlement account opened and maintained by the Claims Administrator with 18 the appropriate amount no later than fourteen (14) calendar days following the later of 19 the notice of entry of this order and the receipt by Defendant of the calculation of 20 payroll tax from the Claims Administrator, and the Claims Administrator shall calculate 21 and pay the claims of the class members in accordance with the terms set forth in the 22 Agreement and Preliminary Approval Order.

11. The Complaint is dismissed with prejudice.

12. This Court hereby permanently enjoins Plaintiff and all Class Members
who have not timely requested exclusion from the Settlement in accordance with the
Agreement's terms from filing or prosecuting any claims, suits or administrative
proceedings (including filing claims with the Nevada Office of the Labor Commissioner)
regarding claims released by the Settlement.
