This Court, having considered the papers submitted in support of the 2017. application of the parties, HEREBY ORDERS THE FOLLOWING:

- This Court grants preliminary approval of the Settlement and the Settlement 1. Classes based upon the terms set forth in the Joint Settlement Agreement and Release between Plaintiffs and Defendant ("Settlement") filed herewith. The Settlement appears to be fair, adequate and reasonable to the Class.
- The Settlement falls within the range of reasonableness and appears to be 2. presumptively valid, subject only to any objections that may be raised at the final fairness hearing and final approval by this Court.
- A final fairness hearing on the question of whether the proposed Settlement, 3. attorneys' fees to Class Counsel, and the Class Representative Enhancement Awards should be finally approved as fair, reasonable and adequate as to the members of the Class is scheduled in accordance with the Implementation Schedule set forth below.
- This Court approves, as to form and content, the Notice of Pendency of Class 4. Action, Proposed Class Action Settlement, and Hearing Date for Court Approval ("Notice of Pendency of Class Action"), in substantially the form attached to the Joint Motion of Settlement as Exhibit B, the Claim Form in substantially the form attached thereto as Exhibit C, and the Request for Exclusion Form attached thereto as Exhibit D. This Court approves the procedure for Class Members to participate in, to opt out of and to object to, the Settlement as set forth in the Notice of Pendency of Class Action.
- This Court directs the mailing of the Notice of Pendency of Class Action and 5. Proposed Settlement, and the Claim Forms by first class mail to the Class Members in accordance with the Implementation Schedule set forth below. This Court finds the dates selected for the mailing and distribution of the Notice and the Claim Form, as set forth in the Implementation Schedule, meet the requirements of due process and provide the best notice practicable under the circumstances and shall constitute due and sufficient notice to all persons entitled thereto.
- It is ordered that the Settlement Class is preliminarily certified for settlement 6. purposes only.
