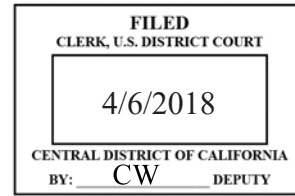

Counsel for Plaintiffs in the above entitled actions, having moved for orders transferring and consolidating *Fernandez, et al. v. Bank of America, N.A., et al.*, Case No. 2:17-cv-06104-MWF-JCx (“Fernandez”) (Docket No. 26) and *Boswell,*


1 *et al. v. Bank of America, et al.*, Case No 2:17-cv-06120-MWF-RAOx  
2 (“Boswell”) (Docket No. 27); and the grounds for transfer and consolidation under  
3 Rule 42(a) of the Federal Rules of Civil Procedure being established,

4 IT IS HEREBY ORDERED that

- 5 1. Both cases have now been transferred to the docket of this Court;
- 6 2. Plaintiffs’ motions are GRANTED;
- 7 3. The Motion to Certify Class filed in the *Boswell* action (Docket No.  
8 26) is denied without prejudice, and may be re-filed subject to the  
9 schedule established by the Court;
- 10 4. The *Fernandez* action and the *Boswell* action are consolidated for all  
11 purposes, including pre-trial and trial activities;
- 12 5. The Clerk shall terminate the *Boswell* action, and all filings shall only  
13 be made in the *Fernandez* (CV 17-6104 MWF (JCx)) action;
- 14 6. Pursuant to the above transfer, any discovery matters that are or may  
15 be referred to a Magistrate Judge shall be directed to Magistrate  
16 Judge Jacqueline Chooljian; and
- 17 7. The Court will schedule a Status Conference to discuss scheduling in  
18 the consolidated actions.
