- This Court grants preliminary approval of the Settlement and the Settlement 1. Classes based upon the terms set forth in the Joint Stipulation of Settlement and Release between Plaintiffs and Defendants ("Stipulation of Settlement") filed herewith. The Settlement appears to be fair, adequate and reasonable to the Class.
- The Settlement falls within the range of reasonableness and appears to be 2. presumptively valid, subject only to any objections that may be raised at the final fairness hearing and final approval by this Court.
- 3.
