1 COMES NOW Plaintiffs Tonya DiMuzio and Megan Grilz on behalf of themselves  
2 and all others similarly situated and allege the following:

3 All allegations in the Complaint are based upon information and belief except for  
4 those allegations that pertain to the Plaintiffs named herein and their counsel. Each  
5 allegation in the Complaint either has evidentiary support or is likely to have evidentiary  
6 support after a reasonable opportunity for further investigation and discovery.

### 7 JURISDICTION AND VENUE

8 1. This Court has original jurisdiction over the state law claims alleged herein  
9 because the amount in controversy exceeds \$15,000 and a party seeking to recover  
10 unpaid wages has a private right of action pursuant to the Nevada Constitution, Article  
11 15 Section 16, and Nevada Revised Statute ("NRS") sections 608.050 and 608.140. See  
12 *Neville v. Terrible Herbst, Inc.*, 133 Nev. Adv. Op. 95 (Dec. 7, 2017).

13 2. Plaintiffs also claim a private cause of action to foreclose a lien against the  
14 property owner for wages due pursuant to NRS 608.050.

15 3. Plaintiff DiMuzio made a proper demand for wages due pursuant to NRS  
16 608.140 on March 13, 2018.

17 4. Venue is proper in this Court because the Defendant named herein  
18 maintains a principal place of business or otherwise is found in this judicial district and  
19 many of the acts complained of herein occurred in Clark County, Nevada.

### 20 PARTIES

21 5. Plaintiff Tonya DiMuzio (hereinafter "Plaintiff" or "DiMuzio") is a natural  
22 person who is and was a resident of the State of Nevada and has been employed by  
23 Defendant as a non-exempt hourly employee from 2007 to the present.

24 6. Plaintiff Megan Grilz (hereinafter "Plaintiff" or "Grilz") is a natural person  
25 who is and was a resident of the State of Nevada and had been employed by Defendant  
26 as a non-exempt hourly employee from on or about August 2002 to February 2016.

27 7. Defendant Blazin Wings, Inc. a/k/a and d/b/a Blazin Wings Inc also a/k/a  
28 and d/b/a Buffalo Wild Wings is a foreign corporation registered with the Nevada

1 Secretary of State.

2 8. Defendant Blazin Wings, Inc. holds the fictitious firm name for Buffalo Wild  
3 Wings with Clark County and was doing business in this Judicial District in Clark County,  
4 Nevada where the subject incidences occurred.

5 9. At all relevant times, each Defendant was an agent, employee, joint-  
6 venturer, shareholder, director, member, co-conspirator, alter ego, master, or partner of  
7 each of the other Defendants, and at all times mentioned herein were acting within the  
8 scope and course and in pursuance of his, her, or its agency, joint venture, partnership,  
9 employment, common enterprise, or actual or apparent authority in concert with each  
10 other and the other Defendants.

11 10. At all relevant times, the acts and omissions of Defendants concurred and  
12 contributed to the various acts and omissions of each and every one of the other  
13 Defendants in proximately causing the complaints, injuries, and damages alleged herein.  
14 At all relevant times herein, Defendants approved of, condoned and/or otherwise ratified  
15 each and every one of the acts or omissions complained of herein. At all relevant times  
16 herein, Defendants aided and abetted the acts and omissions of each and every one of  
17 the other Defendants thereby proximately causing the damages as herein alleged.

18 11. The Defendants named herein are the employers of the Plaintiff and all  
19 Class Members alleged herein. The Defendants are employers engaged in commerce  
20 under the provisions of NRS 608.011. The identity of DOES 1-50 is unknown at the time  
21 and the Complaint will be amended at such time when the identities are known to  
22 Plaintiff. Plaintiff is informed and believes that each Defendants sued herein as DOE is  
23 responsible in some manner for the acts, omissions, or representations alleged herein  
24 and any reference to "Defendant" or "Defendants" herein shall mean "Defendants and  
25 each of them."

26 **FACTUAL ALLEGATIONS**

27 12. Plaintiff DiMuzio has been employed by Defendant as a bartender from  
28 2007 to the present.

1 13. Plaintiff Grilz had been employed by Defendant as a bartender from on or  
2 about August 2002 to February 2016.

3 14. Defendant maintains an unlawful policy of not paying daily overtime to non-  
4 exempt hourly employees who earned 1 ½ times less than the applicable minimum wage.

5 15. Plaintiffs have frequently worked over 8 hours in any given workday.

6 16. On many occasions, Plaintiffs have worked a shift until the late evening  
7 hours and then returned early the next morning to work a day shift. The number of hours  
8 worked in a workday under Nevada law was over 8 hours in a 24-hour period of time.

9 17. For instance, during the workweek of September 16, 2017, Defendant  
10 scheduled Plaintiff DiMuzio to work and Plaintiff did work over 8 hours in a 24-hour period  
11 of time. See a true and correct copy of Plaintiff's time sheet attached hereto as Exhibit I.

12 18. In addition, during the workweek of October 28, 2017, Defendant  
13 scheduled Plaintiff DiMuzio to work and Plaintiff did work over 8 hours in a 24-hour period  
14 of time. See Exhibit I.

15 19. Plaintiff Grilz regularly worked a schedule from 4:00 p.m. to midnight on  
16 her first shift then was required to return for an 8:00 a.m. This was especially prevalent  
17 during football season.

18 20. But despite having worked more than 8 hours in a 24-hour period of time,  
19 Defendant failed to compensate Plaintiffs at 1 ½ times their regular rate of pay for the  
20 overtime hours she worked.

21 21. Upon information and belief, Defendant maintains a company-wide policy  
22 and practice of refusing to pay daily overtime wages to Nevada employees who worked  
23 over 8 hours in a workday.

24 22. This "no daily overtime" policy has always been common to all non-exempt  
25 hourly paid employees at Defendant's locations in the state of Nevada.

26 **CLASS ACTION ALLEGATIONS**

27 23. Plaintiffs reallege and incorporate by this reference all the paragraphs  
28 above in this Complaint as though fully set forth herein.

1           24. Plaintiffs bring this action on behalf of themselves and all other similarly  
2 situated employees as a class action under Rule 23 of the Nevada Rules of Civil  
3 Procedure.

4           25. The **Nevada Overtime Class** is defined as "All hourly paid non-exempt  
5 persons employed by Defendant in the state of Nevada who earned less than 1 ½ times  
6 the applicable minimum wage and who worked over eight (8) hours in a workday at any  
7 time within 3 years from March 20, 2018 until judgment."

8           26. The **Waiting Time Penalty Class** is defined as "All Nevada Overtime  
9 Class Members who are former employees of Defendant."

10           27. Class treatment is appropriate under Rule 23's class certification  
11 mechanism because:

12           a. The Classes are Sufficiently Numerous: Upon information and  
13 belief, Defendant employs, and has employed, in excess of 100 Nevada Overtime Class  
14 Members within the applicable time period. Because Defendant is legally obligated to  
15 keep accurate payroll records, Plaintiff alleges that Defendant's records will establish  
16 the members of the Classes as well as their numerosity.

17           b. Plaintiffs' Claim are Typical to Those of Fellow Class Members:  
18 Each Class Member is and was subject to the same practices, plans, or policies as  
19 Plaintiffs: whether Defendant compensated Plaintiffs and members of the Class daily  
20 overtime wages when they worked over 8 hours in a workday and whether members of  
21 the Waiting Time Penalty Class are entitled to waiting time penalties for the failure to pay  
22 them minimum, regular, and overtime wages owed.

23           c. Common Questions of Law and Fact Exist: Common questions of  
24 law and fact exist and predominate as to Plaintiffs and the Class Members, including,  
25 without limitation: whether Defendant failed to pay Plaintiffs and the Class Members one  
26 and one-half times their regular rate for all hours worked in excess of 8 hours a workday  
27 and whether Defendant failed to pay the Waiting Time Penalty Class Members all their  
28 wages due and owing in violation of NRS 608.020-050.

An employer shall pay 1 1/2 times an employee's regular wage rate whenever an employee who receives compensation for employment at a rate not less than 1 1/2 times the minimum rate prescribed pursuant to NRS 608.250 works more than 40 hours in any scheduled week of work.

32. As described above, Defendant maintains a policy and/or practice of illegal shift jamming (i.e., refusing to pay daily overtime when Plaintiffs and members of the Nevada Overtime Class worked over 8 hours in a workday). As a result, Plaintiffs and Nevada Overtime Class Members have been denied overtime compensation according to Nevada law.

33. Wherefore, Plaintiffs demand for themselves and all Nevada Overtime Class Members that Defendant pay Plaintiffs and Nevada Overtime Class Members one and one-half times their "regular rate" of pay for all hours worked in excess of eight (8) hours in a workday during the relevant time period together with attorneys' fees, costs, and interest as provided by law.

**SECOND CAUSE OF ACTION**  
**Waiting Time Penalties Pursuant to NRS 608.020-.050 and 608.140**  
**(On Behalf of Plaintiffs and the Waiting Time Penalty Class)**

34. Plaintiffs reallege and incorporate by this reference all the paragraphs above in this Complaint as though fully set forth herein.

35. NRS 608.140 provides that an employee has a private right of action for unpaid wages.

36. NRS 608.020 provides that "[w]henver an employer discharges an employee, the wages and compensation earned and unpaid at the time of such discharge shall become due and payable immediately."

37. NRS 608.030 provides that "[w]henver an employee resigns or quits his or her employment, the wages and compensation earned and unpaid at the time of the employee's resignation or quitting must be paid no later than...[t]he day on which the employee would have regularly been paid the wages or compensation; or[s]even days after the employee resigns or quits...whichever is earlier."

1 38. NRS 608.040(1)(a-b), in relevant part, imposes a penalty on an employer  
2 who fails to pay a discharged or quitting employee: "Within 3 days after the wages or  
3 compensation of a discharged employee becomes due; or on the day the wages or  
4 compensation is due to an employee who resigns or quits, the wages or compensation  
5 of the employee continues at the same rate from the day the employee resigned, quit, or  
6 was discharged until paid for 30-days, whichever is less."

7 39. NRS 608.050 grants an "employee lien" to each discharged or laid-off  
8 employee for the purpose of collecting the wages or compensation owed to them "in the  
9 sum agreed upon in the contract of employment for each day the employer is in default,  
10 until the employee is paid in full, without rendering any service therefore; but the  
11 employee shall cease to draw such wages or salary 30 days after such default."

12 40. By failing to pay Waiting Time Penalty Class Members their minimum,  
13 regular, and overtime wages in violation of state and federal law, Defendant has failed  
14 to timely remit all wages due and owing to the Waiting Time Penalty Class Members.

15 41. Despite demand, Defendant willfully refused and continues to refuse to pay  
16 Waiting Time Penalty Class Members all the wages that were due and owing upon the  
17 termination of their employment.

18 42. Wherefore, the Waiting Time Penalty Class Members demand thirty (30)  
19 days of pay as waiting penalties under NRS 608.040 and 608.140, and thirty (30) days  
20 of pay as waiting penalties under NRS 608.050 and 608.140, together with attorneys'  
21 fees, costs, interest, and punitive damages, as provided by law.

22 **THIRD CAUSE OF ACTION**  
23 **Injunctive/Declaratory Relief**  
24 **(On Behalf of Plaintiffs and the Nevada Overtime Class)**

25 43. Plaintiffs reallege and incorporate by this reference all the paragraphs  
26 above in this Complaint as though fully set forth herein.

27 44. As Defendant has failed to compensate Plaintiffs and members of the  
28 Overtime Class at the correct overtime wage rate for all the overtime hours that they

1 worked pursuant to NRS 608.018, Defendant has wrongfully withheld wages properly-  
2 owed to the Plaintiffs and the Overtime Class Members.

3 45. Plaintiffs and the Nevada Overtime Class will suffer irreparable injury if  
4 Defendant is not enjoined from the future wrongful retention of wages owed.

5 46. As a result of the aforementioned unlawful payment practices, Plaintiffs  
6 submit that there has been a likelihood of success on the merits that Plaintiffs and the  
7 Class Members have been damaged, that there is irreparable harm, and Plaintiffs  
8 requests that this Honorable Court enter an Order that restrains Defendant from  
9 attempting to enforce the alleged unlawful payment practices.

10 47. Plaintiffs request that this Honorable Court enter a declaration of  
11 rights/obligations in regard to all such unlawful payment practices in this matter.

12 48. Further, disputes and controversies have arisen between the parties  
13 relative to the lawfulness of the payment practices, and Plaintiffs are entitled to have an  
14 order entered pursuant to Chapter 30 of the Nevada Revised Statutes construing the  
15 payment practices and adjudging and declaring Plaintiffs and the Class Members' rights  
16 and remedies thereunder including such an Order stating that such payment practices  
17 are unlawful.

18 49. Plaintiffs have been required to retain the services of an attorney and is  
19 entitled to a reasonable award of attorneys' fees and costs.

20 **PRAYER FOR RELIEF**

21 Wherefore Plaintiffs, by themselves and on behalf of all Class Members, prays for  
22 relief as follows relating to her class action allegations:

- 23 1. For an order certifying this action as a class action on behalf the proposed  
24 Classes and providing notice to all Class Members so they may participate  
25 in this lawsuit;
- 26 2. For an order appointing Plaintiffs as the Representative of the Classes and  
27 their counsel as Class Counsel;

3. For damages according to proof for overtime compensation under NRS 608.018 and 608.140 for all hours worked over 8 hours per day;
4. For waiting time penalties pursuant to NRS 608.040-.050 and 608.140;
5. For a lien on the property where Plaintiffs and all Nevada Class Members labored pursuant to NRS 608.050;
6. For interest as provided by law at the maximum legal rate;
7. For injunctive relief;
8. For declaratory relief;
9. For punitive damages;
10. For reasonable attorneys' fees authorized by statute;
11. For costs of suit incurred herein;
12. For pre-judgment and post-judgment interest, as provided by law; and,
13. For such other and further relief as the Court may deem just and proper.
