- This Court grants preliminary approval of the Settlement and the 1. Settlement Class based upon the terms set forth in the Joint Stipulation of Settlement and Release between Plaintiffs and Defendant ("Stipulation of Settlement") filed herewith. The Settlement appears to be fair, adequate and reasonable to the Class.
- The Settlement falls within the range of reasonableness and appears to 2. be presumptively valid, subject only to any objections that may be raised at the final fairness hearing and final approval by this Court.
- A final fairness hearing on the question of whether the proposed 3. attorneys' fees to Class Counsel, and the Settlement, Representative Enhancement Award should be finally approved as fair, reasonable and adequate as to the members of the Class is scheduled in accordance with the Implementation Schedule set forth below.
- This Court approves, as to form and content, the Notice of Pendency of 4. Class Action and Proposed Settlement and Hearing Date for Final Approval of Settlement ("Notice of Pendency of Class Action"), in substantially the form attached to the Stipulation of Settlement as Exhibit A.
